This letter confirms the discussion between you and Mr. Terry J. Madeda, of my staff to have a Predecisional Enforcement Conference on August 5, 2003, at 9:00 a.m. (CDT) in the Region III office, Lisle, Illinois. The purpose of this meeting is to discuss apparent violations of NRC requirements related to 10 CFR Part 26, "Fitness-For-Duty (FFD) Program and 10 CFR 50.5, Deliberate Misconduct." The NRC Office of Investigation (OI) substantiated that you deliberately failed to take action after receiving information regarding the odor of alcohol on a foreman, and that the you knowingly provided inaccurate information to an OI investigator about the FFD concern that involved the foreman. The meeting will be closed to public attendance and will be transcribed.

We will gladly discuss any questions you may have concerning this matter.





