Please refer to our advance notice of August 21, 2000 (Project code: 1F3-R19/TK2-R18) as per attached.

We were advised by Mitsui/Tokyo today that we might ship additional 45 natural UO2 drums for TK2-R19/TS1-R26, together with 108 UO2 drums (departing Wilmington, NC on Sept. 1, 2000) since our customer in Japan wishes to ship above additional 45 drums. We expect to have final decision within this week.
