Dear Dr. Malik:

This is in reference to your letter dated August 23, 2006 providing additional information to your application for a Nuclear Regulatory Commission license. In order to continue our review, we need the following additional information:

The information you have provided to be approved as an Authorized user on the license is incomplete. 10 CFR 35.290 indicates that 700 hours of training and experience must be shown to include 80 hours of classroom and laboratory experience and work experience under the supervision of an authorized user. You have not indicated clock hours on the NRC 313A form and you have indicated 200 hours of classroom training in one day. The license number you have provided for the supervising individual does not appear to be a valid license number. If you intended to indicate NRC License No. 37-30485-01, this license appears to have terminated licensed activities in March 2005 prior to the indicated supervised period on the NRC 313A form.

Additional information is also needed in item 11a. and 11c. of the NRC 313A. Your preceptor has not indicated that you completed 10 CFR 35.290 (c)(1)(i) or that you are competent to function independently under all of 35.200 (it states only myocardial).
