A preliminary exit briefing was conducted with Mr. David Oetken, Compliance Manager at the conclusion of the onsite inspection. Final exit briefings to discuss the inspection findings were conducted telephonically with you and with Mr. Ken Stankievech, President, on August 24, 2006.
