





**Standard Review Plan Revision**

- Issuance of revision to the SRP by March 2007
  - Schedule to support requirement in "contents of application" regarding *Conformance with the Standard Review Plan (SRP)*.
  - Update conforms to LIC-200, Rev 1, May 8, 2006
  - Using scoping results to inform stakeholders on anticipated changes in the revisions

## SRP Revision (continued)

- Issuing as final SRP section revisions which are available for comment instead of requesting comments on draft SRP sections revisions.
- Comment resolution will be addressed in subsequent SRP revisions.
- Prior to revision to individual sections, comment resolution may establish a basis for how alternatives to the SRP acceptance criteria provide an acceptable method of complying with the NRC's regulations.

## SRP Revision (continued)

- Preliminary revisions to be made publicly available following review and approval of technical and administrative aspects of the update
- Where practical, SRP revisions will be packaged with concurrent Regulatory Guide updates for consideration by the ACRS.
- Formal issuance scheduled for end of March 31, 2007, following reconciliation of Part 52 rulemaking and comments received on concurrent regulatory guide revisions including DG-1145.



## Regulatory Guide Update Program

- Over 400 Regulatory Guides and Draft Guides
  - Prioritized from High to Low
- 63 High Priority RGs and DGs to support new reactor licensing
  - 31 planned for revision by March 2007
  - 28 not needed to be updated by March 2007
  - 4 without sufficient technical basis to support development by March 2007
