In letter AR-06-1579, dated August 14, 2006, Southern Nuclear Operating Company (SNC) submitted an application to the U.S. Nuclear Regulatory Commission (NRC) requesting an Early Site Permit (ESP) for two additional reactors at the Vogtle Electric Generating Plant (VEGP) site near Waynesboro, Georgia. The application was submitted in accordance with Part 52, Subpart A of Title 10 of the Code of Federal Regulations.
