AREVA NP Inc. submitted the Quality Assurance Plan for the U.S. EPR to the U.S. NRC on June 16, 2006 (Reference 1). Subsequently, in a telecon between AREVA and the NRC on September 7, 2006, the NRR Project Manager requested that AREVA resubmit the Quality Assurance Plan as a topical report. Therefore, AREVA requests the NRC's review and approval of document ANP-10266NP, "AREVA NP Inc. Quality Assurance Plan (QAP) for Design and Deployment of the U.S. Evolutionary Power Reactor (U.S. EPR) Topical Report." The QAP topical report, provided as Enclosure 1 of this letter, supersedes document 56-9017592-00 submitted on June 16, 2006 (Reference 1). As discussed during the telecon, AREVA requests review and approval of this Topical Report in the context of the Design Certification Application. Therefore, the representative text of appropriate sections of the Design Certification Document (DCD) Chapter 17, 'Quality Assurance' is provided as Enclosure 2 to provide the context for the NRC's review and approval of the Topical Report. This Enclosure provides the applicable requirements of the eighteen (18) criteria of Appendix B to 10CFR Part 50 as satisfied by the Topical Report.


