SUBJECT: SUMMARY OF APRIL 18, 2006 ANNUAL ASSESSMENT MEETING WITH ENTERGY NUCLEAR OPERATIONS, INC.

On April 18, 2006, at 3:00 p.m., an Annual Assessment Meeting was conducted at the John Carver Inn, Plymouth, Massachusetts, between the Nuclear Regulatory Commission (NRC) and Entergy Nuclear Operations, Inc. (Entergy). The NRC requested the meeting with Entergy management to discuss the NRC's assessment of the safety performance of Pilgrim Nuclear Power Station for the calendar year 2005.

The NRC presented and discussed its assessment of the safety performance of Pilgrim for the period between January 1 through December 31, 2005. The NRC presentation included information on the Reactor Oversight Program (ROP), summary of national performance assessment results, and the results of NRC's performance assessment for Pilgrim. As part of this regulatory performance meeting, Entergy presented its perspective regarding the plant's performance and operation goals for 2006.
