On August 25, 2006, the U.S. Nuclear Regulatory Commission (NRC) completed a security baseline inspection at your Millstone Power Station. The inspection covered one or more of the key attributes of the security cornerstone of the NRC's Reactor Oversight Process. The enclosed report documents the inspection results, which were discussed on August 25, 2006, with Mr. Alan Price, Site Vice-President, and other members of your staff.

The inspection examined activities conducted under your licenses as they relate to security and compliance with the Commission's rules and regulations and with the conditions of your licenses. The inspectors reviewed selected procedures and records, observed activities, and interviewed personnel.
