Dear Mr. Gresham:

By letter to the Nuclear Regulatory Commission (NRC) dated August 18, 2006, Exelon Generation Company, LLC, submitted an affidavit dated July 28, 2006, executed by you requesting that the information contained in the following document be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR), Part 2, Section 2.390:

Westinghouse Electric Company LLC, SG-SGDA-06-20-P-Attachment, Revision 1, "Exelon: Byron Unit 2 and Braidwood Unit 2, Response to Request for Additional Information on FP&L Seabrook License Amendment Request 05-08 Limited Inspection of the Steam Generator Tube Portion Within the Tubesheet (Tac No. MC8554)," dated July 27, 2006

A nonproprietary copy of this document has been placed in the NRC's Public Document Room and added to the Agencywide Documents Access and Management System Public Electronic Reading Room.

The affidavit stated that the submitted information should be considered exempt from mandatory public disclosure for the following reasons:
