**ORGANIZATION CHART FOR THE OFFICE OF FEDERAL AND STATE MATERIALS AND ENVIRONMENTAL MANAGEMENT PROGRAMS (FSME-06-094)**

**Purpose:** To provide the organization chart for FSME, and the staff lists for the Divisions of Materials Safety and State Agreements (MSSA) and Intergovernmental Liaison and Rulemaking (DILR).

**Background:** As you are aware, the Commission approved a reorganization of the Offices of Nuclear Material Safety and Safeguards (NMSS) and State and Tribal Programs (STP) in June of this year. The reorganization merged a portion of NMSS with STP and became effective October 1, 2006.

**Discussion:** Please find enclosed the reorganization chart for FSME, and the staff lists for the FSME/MSSA and FSME/DILR. Additional minor staffing changes will occur due to near term retirements, promotions, attrition, etc., or further alignment of certain program functions. As you will note by the staff lists, most former STP staff are assigned to either the State Agreements and Industrial Safety Branch in MSSA or the Intergovernmental Liaison Branch in DILR. The remaining former STP staff are assigned to the remaining four Branches within MSSA and DILR. No former STP staff were assigned to the Division of Waste Management and Environmental Protection (DWMEP); therefore, DWMEP's staff list is not enclosed. All current staff phone numbers, mailing addresses and offices remain unchanged at this time.

We hope you find this information useful. We are committed to continue our close coordination with the States to help ensure the nationwide safe use of radioactive materials.
