This is in reference to your letter dated September 27, 2006 requesting to amend Nuclear Regulatory Commission License No. 29-28341-02MD. In order to continue our review, we need the following additional information:

1. In support of your request to authorize Mr. Anthony Ponterio, R.Ph. as the Radiation Safety Officer (RSO), in which the RSO training requirements are as stated under 10 CFR 35.50, please provide an attestation, signed by a preceptor Radiation Safety Officer, that the individual has satisfactorily completed training in the radiation safety, regulatory issues, and emergency procedures for the types of uses on the license and has achieved a level of radiation safety knowledge sufficient to function independently as a Radiation Safety Officer for a medical use licensee.
