NEI Proposed Issues

1. NRC's new interpretation regarding use of equipment shared between units. Utility survey found that this affects numerous plants.
2. NRC regional inspector's (mostly Region III) wide variations in opinion as to what is expected to be in pre-fire strategy plans. Utility research into the regulatory framework has not provided conclusive guidance as to what hazards should/shouldn't be included in the pre-fire plans. Utilities appear to be vulnerable to each inspector's opinion about what should be included/excluded. Some utilities are developing writer's guidance for pre-fire plans to try and stabilize the variability in inspector's opinions.
