Dear Ms. Weidner:

Please terminate the above referenced radioactive materials license. Three of the four remaining sources have been removed from the HDR units and returned to the manufacturer, Nucletron. I have attached Nucletron Service Reports from the removal operation. The source in the fourth unit has been in storage for about 3 years and the estimated source strength is approximately 10 microcuries. We have arranged with Nucletron to remove the source from the last HDR unit on September 25, 2006 and will no longer possess radioactive materials. We do not intent to continue in the business of providing HDR services.

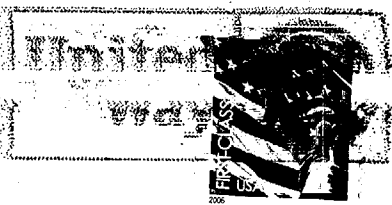
