PURPOSE: On September 28, 2006, the NRC made available draft final rule language for 10 CFR Part 52, "Licenses, Certifications, and Approvals for Nuclear Power Plants," and for other 10 CFR Parts affected by the Part 52 rulemaking. This draft rule language is part of a final rulemaking to enhance 10 CFR Part 52 based on lessons learned during early site permit and design certification reviews and on discussions with stakeholders about the early site permit, design certification and combined license review processes. The NRC staff is convening this public meeting for the purpose of answering stakeholder questions about the rule language.
