

I, James G. Luehman, being first duly sworn, do hereby state as follows:



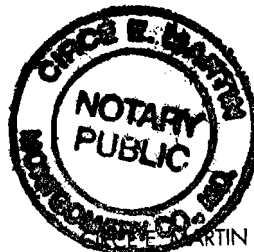
