Based on this review, we have determined that additional information is required on specific changes made during calendar year 2005 to verify the requirements of 10 CFR 70.72 (c) were met. FCE 05-0203 Classifications/Descriptions of Centrifuge Transporters

(1) the facility change package - which should detail the evaluation performed in accordance with 10 CFR 70.72 (a); and

(2) any other explanation on how the individual requirements of 10 CFR 70.72 (c) were satisfied for each change performed.
