

Dear Mr. Jacobsen:

This refers to your October 15, 2004, letter providing this office with Battelle's final status survey report for the sanitary sewer line beneath Lake Battelle and the Lake Battelle Dam. My decommissioning staff has reviewed the referenced information, and has concluded that the information is adequate to demonstrate acceptability for unrestricted release of the former sanitary sewer line, as specified in Title 10, Code of Federal Regulations (CFR), Part 20, Subpart E. We have no further questions regarding this matter. The referenced information is to be maintained pursuant to 10 CFR Part 30, Sections 30.35, "Financial Assurance and Record Keeping for Decommissioning," and Section 30.36, "Expiration and Termination of Licenses and Decommissioning of Sites and Separate Buildings or Outdoor Areas."

In accordance with 10 CFR 2.390 of the NRC's "Rules of Practice," a copy of this letter will be available electronically for public inspection in the NRC Public Document Room or from the Publicly Available Records (PARS) component of NRC's document system (ADAMS). 
