On September 6, 2006, the US Nuclear Regulatory Commission (NRC) completed a physical security inspection at your Humboldt Bay Power Plant, Unit 3. On September 13, 2006, a telephonic exit was conducted with Mr. Terry Nelson, Plant Manager (Nuclear), and other members of your staff. The enclosed report presents the scope and results of that inspection.

This inspection was an examination of activities conducted under your license as they relate to security and compliance with the Commission's rules and regulations and with the conditions of your license. The inspection included an examination of selected procedures and representative records, observations of activities, and interviews with personnel.

In accordance with 10 CFR 2.390 of the NRC's "Rules of Practice," a copy of this letter will be available electronically for public inspection in the NRC Public Document Room or from the Publicly Available Records (PARS) component of the NRC's document system, ADAMS.
