Dear Mr. McCormick:

Thank you for your letter dated September 22, 2006, in response to our letter and Notice of Violation dated August 24, 2006. We have reviewed your letter and find it responsive to the concerns raised in our Notice. We understand that although one of the Wyoming locations listed on your license may not have been "vacated," Century Geophysical Corporation (Century) no longer uses the property as a storage location for licensed material. In addition, you have submitted a request to our Licensing Branch to update your license by deleting locations of possession and use of byproduct material that are no longer used by Century; by adding Century's location in Gillette, Wyoming; and by committing to add Century's future location in Sheridan, Wyoming.

We have no further questions regarding your response to the Notice. We will review the implementation of your corrective actions during a future inspection to determine that full compliance has been achieved and will be maintained.
