The sealed sources will be used in petroleum exploration well logging service operations. The exported material will remain in the custody of PES employees and when not mobilized in support of field activities will be stored in secure PES facilities. Since India is on the restricted destinations list (110.29), before taking action on this new request, we would appreciate your views, in accordance with established procedures and from the overall perspective of the Executive Branch, as to whether the requested export meets the applicable criteria in the Atomic Energy Act of 1954, as amended.
