

The purpose of this modification is to exercise the first option year under the subject contract in accordance with Paragraph I.3, 52.217-9 - Option to Extend the Term of the Contract, at the total estimated cost reflected under Attachment 1, B.1, Schedule of Prices. As a result, the ceiling amount of the subject contract is increased by \$25,000, from \$70,000 to \$95,000. This modification also provides incremental funding in the amount of \$25,000, thereby increasing the obligated amount of the contract from \$70,000 to \$95,000.

By exercising the first option year, the period of performance of the contract is extended from September 30, 2006 and will expire on September 29, 2007.

Accordingly, the following changes are hereby made:

1. Under Paragraph B.3 - CONSIDERATION AND OBLIGATION, the first sentence of Subparagraphs (a) and (b) are hereby deleted in their entirety and substituted in lieu thereof the following:
 - “(a) The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$95,000.
 - (b) The amount presently obligated with respect to this contract is \$95,000.”
2. Under Paragraph F.2 - Duration of Contract Period, the first sentence is hereby deleted in its entirety and substituted in lieu thereof the following:

“F.2 DURATION OF CONTRACT PERIOD (MAR 1987)
Alternate 4 (JUN 1998)

The ordering period for this contract shall commence on September 30, 2006 and will expire on September 29, 2007.

A summary of obligations for this contract from award date through the date of this action is provided below:

Total FY05 Obligations.....	\$ 70,000
Total FY06 Obligations	\$ 25,000
Cumulative Total of NRC Obligations.....	\$ 95,000

This modification obligates FY06 funds in the amount of \$25,000.

All other terms and conditions under this contract remain unchanged.
