P R O C E E D I N G S

CHAIRMAN KLEIN: Before we start our briefing, I think, Madam Secretary we have an affirmation?

ANNETTE VIETTI-COOK: Yes. The Commission is being asked to act on a final rule amending Parts 20 and 32 of Title 10 of the *Code of Federal Regulations*. The amendments establish the regulatory foundation for the National Source Tracking System. The final rule requires licensees to report transactions involving the manufacture, transfer, receipt, disassembly, and the disposal of nationally tracked sources.

Chairman Klein and Commissioners Merrifield and Lyons voted to approve the publication and implementation of this final rule under the NRC's authority to protect public health and safety. Commissioners McGaffigan and Jaczko disapproved issuing the final rule under the Commission's public health and safety authority and would have preferred to issue it under NRC's common defense and security authority.

COMMISSIONER JACZKO: Aye.

COMMISSIONER LYONS: Aye.

ANNETTE VIETTI-COOK: Commissioner McGaffigan had previously voted by Notation Vote and had he been here he would have affirmed his prior vote. That's all I have.
