FISCAL YEAR (FY) 2007 MASTER INSPECTION PLAN

Dear Mr. Hackman:

In accordance with NRC Manual Chapter 2602, "Decommissioning Oversight and Inspection Program for Fuel Cycle Facilities and Materials Licensees," NRC Region III staff and management have developed a Master Inspection Plan (MIP) for the Hematite facility. The plan is projected based on your proposed schedule of decommissioning activities for the site from November 2006 through September 2007 (FY2007). The plan outlines how we intend to focus our Regional inspection resources to address significant ongoing decommissioning activities.

Because the FY2007 MIP is based on your proposed schedule of significant decommissioning activities, the plan and the focus of NRC inspection activities may change to reflect a change in your planned decommissioning activities or your performance. In order to ensure that the MIP remains current, we request that you keep the Decommissioning Branch staff informed of any significant changes in your proposed schedule of decommissioning activities. You will be informed of any significant changes to the Hematite FY2006 MIP.

We project that the Region will conduct two to three inspections, which will require approximately 200 NRC inspector hours during FY2007. The inspection procedures, which we may use during our inspections, are listed below. The use of specific procedures will depend on the decommissioning activities being conducted.
