The U.S. Nuclear Regulatory Commission (NRC) intends to publish a final rule in the *Federal Register* that will amend Parts 20 and 32 of Title 10 of the Code of Federal Regulations to establish the regulatory framework for the National Source Tracking System. The amendments will require licensees to report transactions involving the manufacture, transfer, receipt, disassembly, and disposal of nationally tracked sources. The information from these transaction reports will provide the input for a National Source Tracking System and ultimately provide an historical account of each nationally tracked source. Licensees will also be required to provide information on their existing inventory of nationally tracked sources at the time the rule is implemented.

This final rule will apply to NRC licensees; Agreement States will impose legally binding requirements to their licensees. Although this final rule imposes a new information collection requirement on licensees that possess nationally tracked sources, we believe that this regulatory burden is justified. The National Source Tracking System will be part of a comprehensive radioactive control program for the radioactive materials of greatest concern.
