

The purpose of this modification is to (1) provide incremental funds in the amount of \$11,930.00 thereby increasing the NRC obligations from \$210,000.00 to \$221,930.00. Accordingly the contract is modified as follows:

Refer to Section, B.3,"CONSIDERATION AND OBLIGATION—COST REIMBURSEMENT" (JUN 1988) ALTERNATE I (JUN 1988), paragraph (b) is deleted in it's entirety and replaced with the following:

"(b) The amount presently obligated by the Government with respect to this contract is \$221,930.00."
