

MATERIALS LICENSE

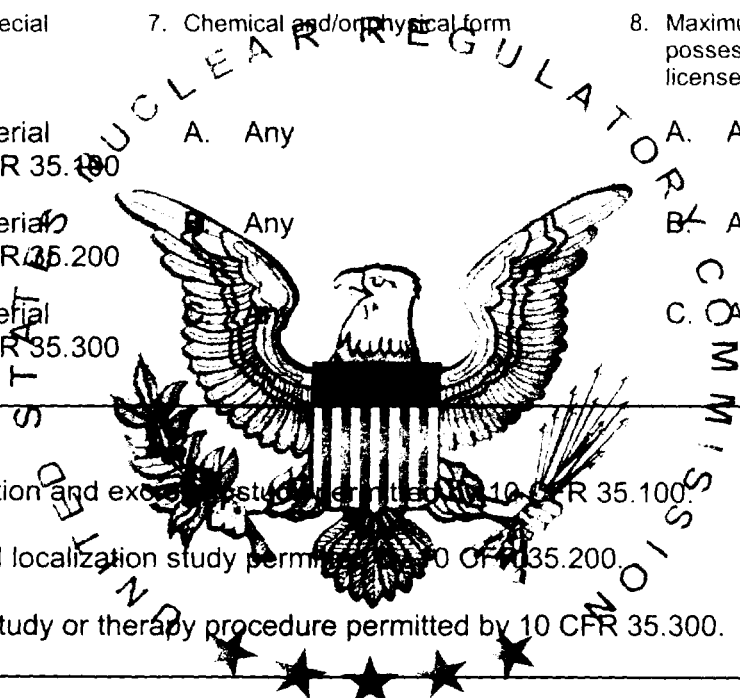

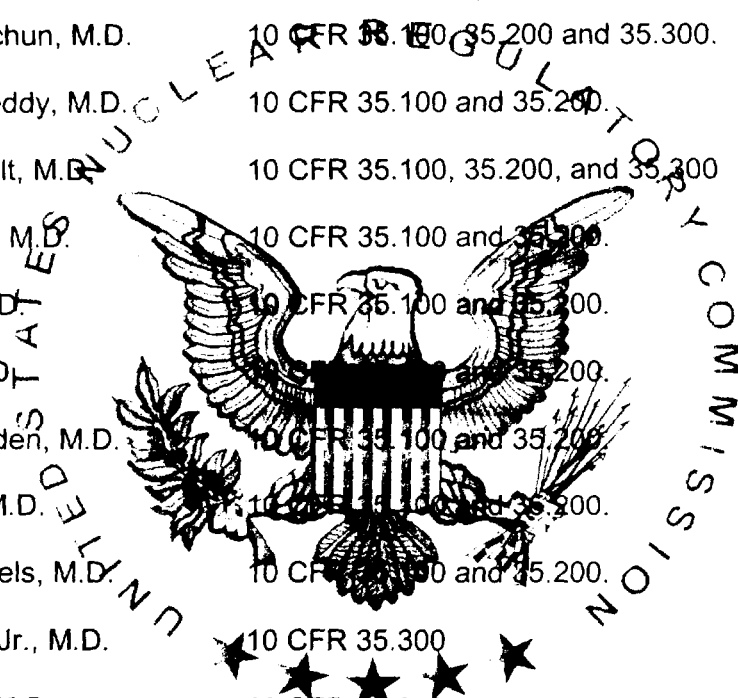


