The purpose of this modification is to exercise the fourth option year under the subject contract in accordance with Paragraph C.6 - Option to Extend the Term of the Contract, at the total estimated cost reflected under Paragraph B.1 - Schedule of Items and Prices, Subparagraph (c). As a result, the ceiling amount of the subject contract is increased by \$248,306.02, from \$822,421.03 to \$1,070,727.05. This modification also provides incremental funding in the amount of \$248,306.02, thereby increasing the obligated amount of the contract from \$822,421.03 to \$1,070,727.05.

By exercising the fourth option year, the period of performance of the contract is extended from December 31, 2006 to December 31, 2007.

Accordingly, the following changes are hereby made:

1. Under Paragraph B.2 - CONSIDERATION AND OBLIGATION, the first sentence of Subparagraphs (a) and (b) are hereby deleted in their entirety and substituted in lieu thereof the following:
 - "(a) The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$1,070,727.05.
 - (b) The amount presently obligated with respect to this contract is \$1,070,727.05."

2. Under Paragraph B.13 - PERIOD OF PERFORMANCE is hereby deleted in its entirety and substituted in lieu thereof the following:

"B.13 PERIOD OF PERFORMANCE

This contract shall commence on December 13, 2002 and will expire on December 31, 2007.
3. Under Paragraph C.3 - ORDERING, Subparagraph (a) is hereby deleted in its entirety and substituted in lieu thereof the following:

"C.3 ORDERING

 - (a) Any supplies and services to be furnished under this contract shall be ordered by issuance of delivery orders or task orders by the individuals or activities designated in the Schedule. Such orders may be issued from December 13, 2002 through December 31, 2007."

4. Under Paragraph C.4 - ORDER LIMITATIONS, Subparagraph (b)(2) is hereby deleted in its entirety and substituted in lieu thereof the following:

"(b) Maximum order. The Contractor is not obligated to honor--

(2) Any order for a combination of items in excess of \$1,070,727.05."

5. Under Paragraph C.5 - INDEFINITE QUANTITY, Subparagraph (d) is hereby deleted in its entirety and substituted in lieu thereof the following:

"(d) Any order issued during the effective period of this contract and not completed within that period shall be completed by the Contractor within the time specified in the order. The contract shall govern the Contractor's and Government's rights and obligations with respect to that order to the same extent as if the order were completed during the contract's effective period; provided, that the Contractor shall not be required to make any deliveries under this contract after December 31, 2007."
