

 1. Section B.3 CONSIDERATION AND OBLIGATION. This modification obligates \$ 80,000.00, increasing the obligated from \$340,000.00 to \$420,000.00. Accordingly, paragraph (c), first sentence is revised to read as follows:
 (c) The amount presently obligated with respect to this contract is \$420,000.00, of which the sum of \$391,061.45 represents reimbursable costs and of which \$28,938.55 represents the fixed fee.
