Dear Mr. Gaines and Ms. Campbell:

This letter is in response to the inspection conducted on June 6, 2006 and your letter dated September 5, 2006 and we were notified for four NRC requirements to be fulfilled that are as follows:

Violation No. A:

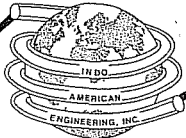
- (1) The reason for violation is that we have missed to inform NRC.
- (2) Corrective action was taken by writing a letter and amending our license for the new location dated June 7, 2006 and response was received from NRC on June 14, 2006.
- (3) In future, we will make sure that we will inform agencies if we move to new location.
- (4) The full compliance was achieved on or before June 14, 2006.

Violation No. B:

- (1) The reason for violation is that we did not kept survey record of radiation levels in unrestricted and controlled areas to demonstrate compliance with radiation does limits in our old business location.
- (2) Corrective action was taken by submitting leak test reports on our Nuclear Gauges (1) Model 3440, Serial Number 21693; (2) Model 3440, Serial Number 22986 and (3) Model 3430, Serial Number 32250 that were performed by OPCS, 702 West 48th Ave., Unit H, Denver, CO 80216, Telephone: 303-292-2412, to NRC on June 7, 2006.
- (3) In future, we will make sure that records are preserved for old location for individual members of the public.
- (4) The full compliance was achieved on or before June 14, 2006.

Violation No. C:

- (1) The reason for violation is that we did not keep survey of radiation record.
- (2) The Trox Alert was calibrated and performed radiation survey (a) there was no radiation (0.00merm/h) in surrounding area and 0.06merm/h near the storage area.
- (3) Performed radiation level measurement annually and keep proper records for NRC review and comments will take the corrective action.
- (4) The full compliance was achieved before August 8, 2006

Violation No. D:

- (1) The reason for violation is that the documentation were in glove compartment for licensed material in transport vehicle.
- (2) The corrective action will be taken by providing proper documentation in transport vehicle of licensed material and proper types of training will be provided to all our employees who use licensed materials and proper records will be kept for NRC review and comments.
- (3) The proper records will be kept and vehicle will be inspected on regular basis.
- (4) The full compliance was achieved before August 8, 2006
