SUBJECT: WEST PHARMACEUTICAL SERVICES, REQUEST FOR ADDITIONAL INFORMATION CONCERNING APPLICATION TO TERMINATE LICENSE

Dear Mr. Paul G. Diorio, Director - Safety, Health, and Security

The e-mail is a request for additional information concerning the request to terminate your radioactive material license number 37-30229-01. The following additional information is requested.

- 1) 10 CFR 30.51(d) requires that you submit all records of sewage disposal of materials with a half-life of 120 days or more prior to license termination. Please submit all of these records, state that you no longer have these records, or that all records have already been submitted to the NRC.
- 2) 10 CFR 30.51(d) requires that you submit all records of liquid scintillation counting medium or animal tissue which was disposed as non radioactive material as allowed by 10 CFR 20.2005. Please submit all of these records, state that you no longer have these records, or that you were not required to have these records.
- 3) 10 CFR 30.51(d) requires that you submit records as required by 10 CFR 20.2103(b)(4). This is the records of the results of measurements and calculations used to evaluate the release of radioactive effluents to the environment. Please submit all of these records, state that you no longer have these records, or that your were not required to keep these records.
- 4) Please state the last date of use with licensed materials.
- 5) Please confirm that you no longer used the Waste Storage Area for licensed material after your survey of January 30, 2003.
- 6) Please confirm that you no longer used licensed materials in the Radioisotope Laboratory after your survey of February 14, 2005.

Please note that you may not reply to this letter by return e-mail. Your reply must be in writing by letter or facsimile (610-337-5269). If we do not receive a reply from you within 30 calendar days from the date of this e-mail, we will assume that you do not wish to pursue your application.
