

The purpose of this modification is to provide incremental funding which hereby increases the obligated amount by \$217,000.00 from \$200,000.00 to \$417,000.00. Accordingly, the following change is hereby made:

Under Subsection B.3 - CONSIDERATION AND OBLIGATION -COST PLUS FIXED FEE (JUN 1988) ALTERNATE I (JUN 1991) paragraph c is deleted in its entirety and the following is substituted in lieu thereof:

"c The amount currently obligated by the Government with respect to this contract is \$417,000 of which the sum of \$386,111 represents the estimated reimbursable costs, and of which \$30,889 represents the fixed fee."

All other terms and conditions under this contract remain unchanged including the ceiling amount of \$418,932.00.

This modification obligates FY 2006 funds in the amount of \$217,000.00.
