

The purpose of this modification is to correct an administrative error in the amounts specified for the obligated reimbursable costs and the obligated fixed fee on Modification No. 007 Accordingly, the contract is hereby modified as follows:

Under Section B.3, CONSIDERATION AND OBLIGATION – COST PLUS FIXED FEE (JUN 1988) ALTERNATE (JUN 1991), paragraph (c) is deleted in its entirety and replaced with the following:

“(c) The amount currently obligated by the Government with respect to this contract is \$2,248,000.00, of which the sum of \$2,095,787.52 represents the estimated reimbursable costs, and \$152,212.48 represents the fixed fee.”

All other terms and conditions of this contract remain the same.
