Request to Remove Connecticut Yankee Atomic Power Company (CYAPCO) from the Registered Users List of Various Certificates of Compliance

On December 5, 1996, CYAPCO notified the NRC of the permanent cessation of operations at the Haddam Neck Plant (HNP) and the permanent removal of all fuel assemblies from the reactor vessel and their placement into the spent fuel pool. Following the cessation of operations, CYAPCO began to decommission the HNP. On March 30, 2005, all spent nuclear fuel and Greater Than Class C (GTCC) waste were transferred from the spent fuel pool to the Independent Spent Fuel Storage Installation located at the HNP site. At present, CYAPCO is in the final stage of decommissioning the HNP. Therefore, CYAPCO no longer has a need to be a registered user for the shipping casks identified in the attachment. Accordingly, CYAPCO hereby requests the NRC to remove its name from the Registered Users List for the attached Certificates of Compliance.
