
To Whom It May Concern:

The following responses are submitted in support of our pending amendment application. Each response will correspond to the question addressed in your letter.

- a. In regards to the radiation safety program, we will delegate full authority and control to Michael W. Lairmore. In addition we will display the "Model Delegation of Authority" to notify the staff working at the imaging center of the change in Radiation Safety Officer. a copy of this posting is provided below:

- b. Institutional management will allocate funds for the radiation safety program, based on the consultant RSO's recommendations of the program's needs. Specific monetary expenditures will be discussed between the management representative and radiation safety officer and expenditures initiated by the office manager. The consultant RSO will follow-up on all requested expenditure of funds to assure appropriate implementation.
- c. At the present time, Mr. Lairmore is the radiation safety officer at Manassas Heart Center, Manassas, VA, NRC 45-25607-01. The consultant RSO will allocate time as needed for the performance of his duties at this imaging center. In addition, the consultant RSO will conduct quarterly audits of the radiation safety program. A summary report is placed on file for future inspection.
- d. In the RSO's absence, Dr. Kim, will serve as the point of contact.
- e. The consultant RSO will be available at all time to respond to radiation safety and operational issues that arise during the conduct of the radiation safety program.
