The Contractor shall provide a participant kit for each trainee and other pertinent documentation to assist the trainees in successfully completing the training course. In addition, the Contractor shall provide a two-disk video library of the "7 Habits of Highly Effective People" required for the "7 Habits Signature Workshop". Participant kits consist of a manual, DVD, audio CD, talking stick, Quadrant II doorhanger, 360 benchmark, and Franklin Planner starter kit (classic size, including planner pages and forms for 1 year)."
