The purpose of this modification is to accomplish the following:

1. Exercise Option Year Two of the delivery order in accordance with Federal Acquisition Regulation Clause (FAR) 52-217-9, entitled "Option to Extend the Term of the Contract," and Subsection C.12, entitled, "Period of Performance," thereby extending the term of the order through September 29, 2007. This modification hereby incorporates, by reference, the September 5, 2006, email from David Silverman, Vice President, ProSight, Inc., in which ProSight waived its right to the 60 day preliminary written notification of the Government's intent to exercise this option.
2. Exercise the option for CLIN 013, On-Call Database Administrator Support, pursuant with Subsection C.17, FAR Clause 52.217-7, Option for Increased Quantity - Separately Priced Line Item, thereby increasing the total estimated ceiling amount, and the obligated amount, for Database Administrator (DBA) support services by \$37,502.00, from \$150,008.00 to \$187,510.00.
3. Exercise the option for CLIN 015, Option Year 2 - Software Maintenance Support Services, in the amount of \$16,372.80, and CLIN 019, Fast Track for CPIC Budgeting - Budget Year 2009 Annual Review, in the amount of \$44,515.92, pursuant with Subsection C.17, FAR Clause 52.217-7, Option for Increased Quantity - Separately Priced Line Item, thereby increasing the firm-fixed amount, and the obligated amount, for the fixed-price products and services by \$60,888.72, from \$560,660.40 to \$621,549.12.
4. Increase the estimated amount (ceiling) of the delivery order (Base Year, Option Year 1, and Option Year 2) by \$98,390.72, from \$885,673.40 to \$984,064.12.
5. Obligate FY06 funds in the amount of \$98,390.72, thereby increasing the obligated amount of the delivery order from \$885,673.40 to \$984,064.12.

"C.21 CONSIDERATION AND OBLIGATION - FIRM-FIXED PRICE

The firm-fixed price of this contract for CLINS 001-008, 014, 015, 018, and 019 is **\$621,549.12**.

C.22 CONSIDERATION AND OBLIGATION - DELIVERY ORDERS

(a) The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this delivery order for CLINS 009, 010, 011, 012, and 013, Database Administrator Support, is **\$187,510.00**. The Contracting Officer may unilaterally increase this amount as necessary for orders to be placed with the contractor during the contract period provided such orders are within any maximum ordering limitation prescribed under this delivery order.

(b) The amount presently obligated with respect to this contract for CLINS 009, 010, 011, 012, and 013, Database Administrator Support, is **\$187,510.00**. The Contracting Officer may issue orders for work up to the amount presently obligated. This obligated amount may be unilaterally increased from time to time by the Contracting Officer by written modification to this delivery order. The obligated amount shall, at no time, exceed the delivery order ceiling as specified in paragraph a above. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this delivery order. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk.

(c) The total estimated amount of this delivery order (ceiling), and the amount obligated, for the products/services ordered, delivered, and accepted under this delivery order for CLINS 021, 022, and 023, software and professional services for FastTrack Project Portfolio Management (PPM) Solution, is **\$175,005.00.**"

3) Subsection C.12, PERIOD OF PERFORMANCE, is deleted in its entirety and substituted with the following in lieu thereof:

"C.12, PERIOD OF PERFORMANCE

The period of performance for this contract shall commence on September 30, 2004, and will expire on September 29, 2007. The term of this contract for renewal of maintenance may be extended at the option of the Government for an additional two one-year periods."
