This letter serves as a notice that GE Morris Operation has scheduled an Emergency Plan exercise for Monday, November 27, 2006 at 1030 hours. The exercise shall satisfy the requirements of 10CFR72.32(a)(12).

The exercise shall simulate what we believe to be a potential incident, a worker injured in a radiologically contaminated area at Morris Operation. We intend to have Coal City EMS respond to the incident, however, no other outside agencies are expected to respond (i.e. Grundy County Sheriff, Morris Hospital, etc).

You and your office are invited to participate in the critique session immediately following termination of the exercise.

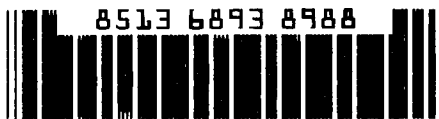
