Dear Ms. Acors:

This is in reference to your letter dated August 15, 2006 requesting to amend Nuclear Regulatory Commission License No. 45-30875-01. In order to continue our review, we need the following additional information:

1. Specific information is needed to address each of the requirements in 10 CFR 35.290 (c) (1) for Dr. Askew. This information

is normally provided on an NRC 313A form which is available in NUREG 1556, Vol.9, Rev. 1. Each relevant section should be completed. The attestation statement should indicate that the individual satisfactorily completed the requirements in paragraph (c)(1) of 10 CFR 35.290 if true.

Please complete and submit the appropriate forms.

2. Additional clarification is needed on the move. Do you want to maintain the Suite 280 on the license address? If you desire to remove the 280 Suite address you will need to provide information on the disposition of all byproduct materials at that location. Additionally you need to provide survey information to show that the facility was left free of significant contamination. Normally this includes a final survey and leak test results for any sealed sources to show they did not leak while in your possession at that location.
