

The purpose of this modification is to provide incremental funding in the amount of \$60,000.00 which increases the obligated amount from \$283,227.00 to \$343,227.00. Accordingly the contract is modified as follows:

1) Refer to Section B.3, "CONSIDERATION AND OBLIGATION- COST PLUS FIXED FEE (JUN 1988) ALTERNATE 1 (JUN 1991)", paragraph (b) is deleted in its entirety and replaced with the following:

"(b) The amount currently obligated by the Government with respect to this contract is \$343,227.00, of which the sum of \$317,802.77 represents the estimated reimbursable costs, and of which \$25,424.23 represents the fixed fee."

A summary of obligations for this contract, from the date of award through this action is given below:

Total FY05 Obligations	\$120,000.00
Total FY06 Obligations	\$163,227.00
Total FY07 Obligations	\$ 60,000.00
Cumulative Total of NRC Obligations	\$343,227.00

This modification obligates FY07 funds in the amount of \$60,000.00.

All other terms and conditions remain the same including the contract ceiling of \$372,902.00.
