

The purpose of this modification is to provide incremental funding in the amount of \$50,000.00. Therefore, the amount obligated is increased by \$50,000.00 from \$1,408,900.00 to \$1,458,900.00. Accordingly, the contract is modified as follows:

Section B.3 Consideration and Obligation – Cost Plus Fixed Fee, paragraph (c) and (d) are deleted in their entirety and replaced with the following:

- (c) The amount currently obligated by the Government with respect to this contract is \$1,458,900.00 of which the sum of \$1,366,621.22 represents the estimated reimbursable costs, and \$92,278.78 represents the fixed fee.
- (d) It is estimated that the amount currently allotted will cover performance through January 1, 2007.

A summary of obligations, from the award date through the date of this modification is provided below:

This modification obligates FY07 funds in the amount of \$50,000.00.

All other terms and conditions, including the ceiling amount of \$1,561,255.00 (of which includes the fixed fee of \$98,753.00) remain the same.
