In a previous letter dated May 13, 2005, P.E.T.Net Pharmaceuticals, Inc. notified your office that the ownership of CTI Molecular Imaging, Inc. including P.E.T.Net Pharmaceuticals, Inc. had been acquired by Siemens Medical Solutions USA, Inc.
