The purpose of this letter is to advise you of the intention of the Herbert J. Thomas Memorial Hospital Association to acquire all of the stock of Charleston Hospital, Inc., the owner and operator of St. Francis Hospital (the "Hospital"). The projected closing date for this transaction is December 31, 2006. Following this transfer of stock, Charleston Hospital, Inc. will continue to own and operate the Hospital under the same name. Charleston Hospital, Inc. will be converted to a non-stock, non-profit corporation.

We do not believe that this transaction constitutes a change of ownership, or requires any action to be taken with respect to the license referenced above.
