Pursuant to 10 C.F.R. § 2.336(d), Entergy Nuclear Vermont Yankee, LLC and Entergy Nuclear Operations, Inc. ("Entergy") hereby supplements its disclosures as follows. Entergy is providing by separate cover letter to the parties (Vermont Department of Public Service, the New England Coalition, and the NRC Staff) eleven compact disks. Vermont Yankee Reactor Vessel Stress Report 9-6201-1 by Chicago Bridge and Iron (CB&I)


Sections S4/T4 for feedwater nozzle from Original CB&I Stress Analysis for Reactor Vessel

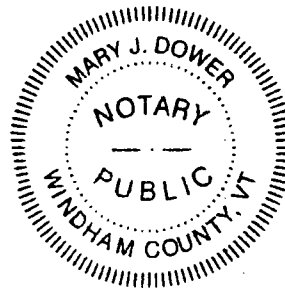
