This is in reference to your letter dated May 23, 2000 requesting to amend Nuclear Regulatory Commission License No. 29-01022-07. In order to continue our review, we need the following additional information:

1. Based on a telephone conversation with Barry Silber on June 20, 2000, we understand that this request is a one-time action to re-install the [] that has been in storage in accordance with the letters dated March 10 and 13, 1998 and April 2, 1998. If our understanding is incorrect, please inform us in writing.
2. Describe, if any, differences or changes in the [] facility where the [] will be installed, from the description provided in the letters dated March 10 and 13, 1998 and April 2, 1998.
3. The procedures submitted with your letter dated May 23, 2000, are copies of the [] procedures for initial assembly and installation of a new [] after its receipt at the site in its shipping crate. Describe any differences or changes you will make to these procedures for your situation of moving the [] from its storage area [].
4. Condition 18 of Amendment 29 of your license prohibits you from repairing, replacing or altering the electrical or mechanical systems that control source movement or shielding movement, the irradiator's shielding or sealed source, safety interlocks, or any component that may affect safe operation of the irradiator. Describe which of these activities, if any, for which you are requesting authorization.
