2) Physical Description

This shipment consists of 44 x 48Y Cylinders loaded on 2 lash barges (22 cylinders per barge). RADIOACTIVE MATERIAL, URANIUM HEXAFLUORIDE, non fissile or fissile-excepted. Total net weight of U – 362,340 kgs.

3) Transportation and Route Schedule
