Under a schedule that the Board previously approved (see the Board's December 11, 2006 e-mail notifying the parties that the Board had approved certain requested scheduling changes), counsel for Mr. Geisen would have to file today their Opposition to NRC Staff's December 1, 2006 Motion to Compel regarding NRC Staff's Interrogatories (Nos. 16-20, 22-29) and Requests for Admission (Nos. 1-4).
