Dear FOIA Officer:

This letter is a Freedom of Information Act request pursuant to 5 U.S.C. § 552 ("FOIA"), and the FOIA regulations of the Nuclear Regulatory Commission ("NRC"), 10 C.F.R. Part 9. We hereby request the following documents:

1. A copy of all documents referring or relating to the transfer of the Facility Operating License for the Vermont Yankee Nuclear Power Station from Vermont Yankee Nuclear Power Corporation to Entergy Nuclear Vermont Yankee, LLC and Entergy Nuclear Operations, Inc.<sup>1</sup>

As used herein, the term "document" includes, without limitation, records, memoranda, decisions, correspondence, telegrams, notes, computer or electronic mail (e-mail), internal messages and memoranda, reports, estimates, compilations, studies, tables and tabulations, computer-stored or computer-readable data, computer printouts, audited and un-audited financial statements, accounting records, applications, check registers, checks, teletype, receipts, messages, and any other communication of any type. This FOIA request is intended to be interpreted broadly, and should be so interpreted by your office.

We hereby agree to pay all appropriate fees and copying costs under this request, and specifically authorize you, in advance, to incur fees and costs not to exceed \$300. If you determine that any documents responsive to this request are exempt from disclosure under FOIA or otherwise, please identify the documents withheld and the basis for not releasing them.

Time is of the essence in this FOIA request. Pursuant to the applicable statute and regulation, we hereby request a response from the NRC within the time required by FOIA and its implementing regulations. This letter contains all necessary elements required in a FOIA request. However, if for any reason you conclude that this FOIA request is incomplete, we respectfully request that you identify all deficiencies to us in writing as soon as possible so that we may properly restate our request.


