Atlantic City Electric Company ("Atlantic Electric") is the current owner of a facility known as the B.L. England Generating Station located at 900 North Shore Road, Beesleys Point, New Jersey 08223 (the "Facility"). Atlantic Electric intends to transfer the Facility to RC Cape May Holdings, LLC ("Cape May"). The anticipated date of the transfer of the Facility is January 26, 2007.

Atlantic Electric currently holds a Radioactive Materials License, No. 29-30855-01, for a Californium source. No changes are anticipated with respect to the use and location of the covered source device. Additionally, the Facility name will remain unchanged and it is anticipated that the Facility operations and management will also remain unchanged.

This notice is being provided to you approximately 30 days prior to the anticipated transfer of the Facility. Atlantic Electric hereby requests that, pursuant to NUREG – 1556, Volume 15, Section 5, Change of Control, you provide us with the specific information requests necessary for your evaluation under Sections 5.1 through 5.6 of the regulation.
