SUBJECT

Control No. 315613 -- Re - License amendment request by letter dated July 28, 2006, to change use/storage location listed in License Condition 10 of License No. 13-32182-01, from 3913, Merchant Road, Fort Wayne, Indiana to 3517 Focus Drive, Fort Wayne, Indiana 46818.

SUMMARY

In a telephone conversation with Mr. Anabtawi on this date, I explained that the request should be addressed by two separate amendment requests in that the first amendment needs to be issued before the physical move to the new use/storage location by naming that location as an additional location of use in License Condition 10. Following the move, a second amendment should be requested to change the mailing address and to delete the former location of use/storage listed in License Condition 10 and to authorize its release for unrestricted use. This second amendment request should be supported by written confirmation that 1) all licensed material (Make, Model Number and Serial Number of each device transferred) has been removed/transferred (date of transfer) from the facility to be released, 2) provide copies of leak test records, current as of the date of transfer of all sealed sources, which confirm the non-leaking status of the sources transferred and 3) if it is the situation, confirm that no leaking sealed sources were ever possessed/used at that facility based on routine leak test data. I noted that we can, and will, issue the first of the two amendments based on the information provided in letter dated July 28, 2006. The additional information to address Items 1 through 3 above will need to be provided after the move before we can issue the second amendment.


Also, in accord with current NRC policy in support of security issues, we discussed the need for the licensee to specify a total possession limit, to be added to License Item 8 for each radioisotope (Cesium-137 and Americium-241) listed in License Item 6 of the subject license. I related that the possession limit did not have to be limited to their current total possession but could allow for temporary replacement gauge(s) and/or for planned expansions in gauge usage. After discussion, Mr. Anabtawi requested a possession limit of 50 millicuries for Cesium-137 and 250 millicuries for Americium-241.

Also, Mr. Anabtawi requested that their mailing address be changed with this amendment to include their Post Office Box Number (P.O. Box 8358) and that the Zip Code be changed to add the four digits 8358, as shown on their current letter head, so that they receive this amendment addressed to their current/old address. He also confirmed that their has been no change in name of the licensee or change in ownership.

ACTION REQUIRED

The License reviewer will issue an amendment based on information in letter dated August 28, 2006, authorizing the new location of use/storage and address changes noted above, and will add the possession limits to the license based on the information agreed to as described above. Following the move to the new location, the licensee will seek a follow-up amendment request to reflect their new address and to delete the former location of use/storage from the license and authorize its release for unrestricted use, by addressing the three items listed above.
